This is a singles & doubles handicap tournament, open to all senior men & women within the Rockford Area USBC Association Boundaries.

Handicap will be 90% of the difference between your average and 220.

Average deadline: October 25, 2021.

Bowlers will bowl 3 games on one pair of lanes. Each participant may bowl and enter only once per event.

All prize fees returned 100%. Payout is 1 out of 5 entries. USBC sanctioned rules apply.

Bowlers bowling under participation RULE 300c must have a verifiable average.

Bowlers bowling under participation rule are eligible for prize winnings, but are not eligible for USBC awards.

All bowlers are required to report any previous tournament prize winnings as a condition for entry. USBC Rule 319d

Bowlers must use last years Highest USBC league average of 21 games or more.

If no average last year, use current highest USBC league average as of October 25, 2021. (21 games)

If current season average of at least 21 games at time of bowling exceeds last years highest season average by 10 or more pins, current season average will be used. USBC Rule 319A

USBC rule 319e is waved. Rule 319A Item #3 Applies. All other bowlers bowl scratch.

Each bowler must show Current USBC Sanction Card.

USBC SANCTIONED RULES APPLY.

MUST fill out entry form and mail to the address below on or before November 15, 2021 or contact Tournament Director for other arrangements. Walk-ins allowed if room permits, 30 minutes prior to last squad bowls.

All money must accompany entry blank.
