# Tournament Rules

Handicaps will be based on 90% of the difference between your average and 220. 220 average and over will be scratch. Handicaps will be figured for each bowler for Team, Singles, Doubles and All Events.

Average indicated on the entry blank must be the highest sanctioned league average for the last season regardless of how many leagues bowled in. (minimum of 21 games required). A bowler who does not have a 21 game average for the last season may use this season's average as of Feb. 1, 2022 (21 games required). All others will bowl scratch. Under no circumstances will handicaps be increased after participant has bowled.

Average established in Summer Leagues will not be acceptable.

When a tournament uses the previous season's average and at the time of bowling the entrant has a current season's average for a 21 or more games which is 10 pins or more higher than the previous season's average, the bowler must use his current average for entry in the tournament.

U.S.B.C. Championship Chevron awards will go to the scratch winners only. Entrants may bowl only once in each event, except they may participate in the FIVE-MAN Championship event as a member of more than one team under the following conditions:

Each bowler must show current 2021-2022 sanctioned membership card.

When more than three bowl together more than once in a five-man team event, the team with which they compete shall be eligible for only one position standing prize.

Association membership eligibility - see Article 3, Section 3,

## U.S.B.C. Constitution

Makeup teams may enter. When a bowler is a member of two or more five-man teams entered in the City Tournament, his first score bowled in the five-man team event shall count towards his all events score.

A minimum of 3 of the 5 team members (1 of 2 in doubles) must have an established average (21 games minimum) in a league sanctioned through the R.B.A.

No entry fees returnable after closing date of entries.

Prize ratio, at least one in five for each event.

Participants should be familiar with U.S.B.C. rule no. 319C concerning re-rating requirements.

Any bowler who reports a lower average than required shall forfeit tournament entry fee and prize winnings.

It shall be each bowler's responsibility to verify the accuracy of his average, whether originally submitted by the bowler, his team captain or others. Failure to use proper average or make correction prior to the completion of the first game of the series shall disqualify score if submitted average is lower than the actual average or base prize winnings on submitted average if it is higher.

Prize fees will be returned 100% in prizes within each event on a handicap basis.

TARDY BOWLERS - Rule 322 will apply.

DISTRIBUTION OF PRIZE FUNDS - Rule 309
